DSHS, 630 F.3d 833 (9th Cir. 2010).).

SUMMARY: Plffs, all females between the ages of 13 and 20, were profoundly victimized over several years by a state-licensed foster parent. Starting in 1997, the Defs. licensed a career criminal with a string of convictions from coast to coast to serve as a foster parent. Plffs claimed the Defs. knew of the foster parent's disqualifying criminal history, yet overrode their licensing regulations and granted him a license to care for children in his home. Between 1997 and 2006, the Defs. received more than two dozen separate reports of abuse, neglect, exploitation and/or licensing violations concerning the same foster parent. The warnings were graphic and compelling. Notwithstanding the foster parent's long criminal history and the litany of the warnings received from several members of the community, the Defs. re-licensed the foster parent three (3) separate times over the period of nearly ten (10) years. Plffs contended during this time, the Defs. failed to take any steps to remove these three victims from the foster home in which they were being beaten, neglected and sexually victimized. Plffs filed suit against DSHS (state law negligence claims) and nine (9) state actors responsible for ensuring Plffs' safety (civil rights claims brought pursuant to 42 U.S.C. § 1983).
